According to email 30 Nov 2021 from the Croatian researcher, there was no record of the marriage in the nearby parish of Šišinec 1878 to 1893 (which includes the village of Gušće, where some later family went to live). According to email 6 Dec 2021 from Croatian researcher, parish of Glina was also searched. Searches were also conducted on Family Search in the records of several surrounding parishes. No record of Jure and Jaga in the Status Animarum ("Book of Souls") for the village of Velika Solina, or anywhere in the parish of Viduševac for the 1860s-1890s.

The researcher has not been able to verify this with the Croatian Registry Office, or the graveyards where Mara is buried (records of maintenance of the grave would indicate next of kin), and there is no probate file for Mara. Note that Mara was 52 years old when she married and unlikely to have had a child.

## **APPENDIX**

The Deceased's mother came from the village of Velika Solina. The village is tiny, and is now part of the municipality of Glina, in Sisak-Moslavina county, Croatia.

During the 1800s in Croatia, birth, death and marriage records were maintained by the church. The Sample family were Roman Catholic. The village of Velika Solina did not have its own Roman Catholic church, but was part of the parish of **Viduševac** aka **Gornij Viduševac**.

The older (pre-1900) birth, death and marriage records are now held at archives. The births of 6 children to the grandparents, Jure Sample and Jaga Gloc were found in the church records of Viduševac. The marriage of Jure Sample and Jaga Gloc was not found in Viduševac parish. Their death records did not state when or where they married, but did indicate that both were born within the parish of Viduševac (Jure in Velika Solina, Jaga in Mala Solina). None of the children's birth records mentioned where their parents married. Generally speaking, in Catholic records for the time in Croatia, if the parents were not married, this would have been noted on the children's baptisms, in that they would be stated to be "illegitimate." As there were no notations on their baptisms to this effect, we can be fairly certain the parents were married.

Sometimes birth/baptismal records have a notation about the person's marriage date and place. A Croatian researcher searched for the grandparents' births in the Viduševac birth registers, but found no record of them there.

The available parish registers for some neighbouring villages/parishes have also been searched for the grandparents' marriage, without success. Searches were done from 1879 to 1893 (from age about 15 or 16 to the year of birth of their first known child).

The records for some of the neighbouring parishes do not appear to be held by the central archives of Croatia, the state archive in Sisak, or online genealogy databases. It is possible that some records no longer exist.

Another source of information about families is the Status Animarum ("Book of Souls"). This is a type of census maintained by the parish priest, which names all residents of the parish, including details such as dates and places of their births, deaths, marriages, and children, and sometimes moves to other parishes/locations. For the parish of Viduševac, there appear to be two sets of books of relevance for this case, one for 1863 onwards, one for 1894 onwards. The Sample family were not mentioned in these records for the village of Velika Solina, nor for any of the other settlements in the Vidusevac parish. Nor were Jure Sample or Jaga Gloc mentioned as part of their families of origin.

None of Joseph Sample's cousins have survived, so family cannot be asked about the details. However, information about the Sample family was provided by Mrs Ljubica Sample, who was married to Ivan Sample, a cousin of Joseph Sample. There was no indication from the information she provided that there were any earlier children born before 1893. She was not willing to compete a Next of Kin form or some other written declaration. However, the Croatian researcher has signed a statement relating to the information about the family that he obtained from her in several telephone conversations he had with her.

#### **NOTES**

Above is a sample report. It would normally consist of documentary evidence of every event. I have not done so in this sample as the events are fictitious.

The **final report** includes all evidence (certificates) obtained about the family and numbered to reflect the footnote of the event they support. Depending on the research there may be appendices with additional supporting information.

Most clients require a **distribution schedule.** This is merely a list of beneficiaries with the fraction of their entitlement.
